

PROSPECTUS SUPPLEMENT
(To prospectus dated on November 21, 2022)

This prospectus supplement amends and supplements the information in the prospectus, dated November 21, 2022 (the “Prior Prospectus”), filed with the Securities and Exchange Commission as a part of our registration statement on Form S-3 (File No. 333-268288), relating to the offer and sale of up to \$7,200,000 of shares of our common stock, \$0.0001 par value per share, pursuant to the Controlled Equity OfferingSM (the “Sales Agreement”) we previously entered into with Cantor Fitzgerald & Co. and Truist Securities, Inc. (together, the “Sales Agents”). This prospectus supplement is registering the offer and sales of up to \$6,433,000 of shares of our common stock. This prospectus supplement should be read in conjunction with the Prior Prospectus, and is qualified by reference thereto, except to the extent that the information herein amends or supersedes the information contained in the Prior Prospectus. This prospectus supplement is not complete without, and may only be delivered or utilized in connection with, the Prior Prospectus and any future amendments or supplements thereto.

Through the date hereof, we have sold 6,972,445 shares of our common stock for gross proceeds of approximately \$14,272,449 in accordance with the Sales Agreement under the Prior Prospectus and the prospectus supplements, dated April 25, 2023, April 27, 2023 and July 14, 2023. We are subject to General Instruction I.B.6 of Form S-3, which limits the amounts that we may sell under the registration statement of which this prospectus supplement and the Prior Prospectus are a part. After giving effect to these limitations and the current public float of our common stock, and after giving effect to the terms of the Sales Agreement, we currently may offer and sell shares of our common stock having an aggregate offering price of up to \$6,433,000 under the Sales Agreement. If our public float increases such that we may sell additional amounts under the Sales Agreement and the registration statement of which this prospectus supplement and the Prior Prospectus are a part, we will file another prospectus supplement prior to making additional sales.

Our common stock is listed on the Nasdaq Global Market under the trading symbol “INAB.” The aggregate market value of our common stock held by non-affiliates as of July 31, 2023 pursuant to General Instruction I.B.6 of Form S-3 is \$62,117,528, which was calculated based on 19,719,850 shares of our common stock outstanding held by non-affiliates and at a price of \$3.15 per share, the closing price of our common stock on June 2, 2023. As of the date hereof, we have offered and sold \$14,272,449 of securities pursuant to General Instruction I.B.6 of Form S-3 during the prior 12 calendar month period that ends on and includes the date hereof. As a result of the limitations of General Instruction I.B.6 of Form S-3, and in accordance with the terms of the Sales Agreement, we are registering the offer and sale of shares of our common stock having an aggregate offering price of up to \$6,433,000 from time to time through or to the Sales Agents.

Investing in our securities involves a high degree of risk.
